Launching an ECI is a door opener! It is a way to place your demands and have a serious chance to make a difference. Our ideas have been taken into the 'housing for all' resolution of the European Parliament recently. It is important to try to collect 1M signatures, but focus mostly on the topic and the content. Place your demands and move on, even if you are not able to collect 1M! The magic happens afterwards, like we are facing with our follow-up project housing4europe. org. We met a lot of people who are joining."

Our ECI was very much in line with the objectives and measures of the European Green Deal, as well as with the UN's 2030 Agenda. Therefore, since the von der Leyen Commission, soil protection issues have been taken up and debated at the EU level. I was invited to present our ideas at the European Parliament meetings. After the European Parliament adopted a resolution on soil protection, the Commission presented the new Soil Strategy: this is exactly what we were asking for with our ECI, only it happened three years later."

Several European citizens' initiatives have **successfully reached** the required number of support statements for the European Commission to take action. Some have resulted in new legislation, while others have had other meaningful results.



Organisers can use free of charge the Commission-run **Central Online Collection System,** enabling online collection of signatures in full compliance with data protection legislation.

# Participatory democracy at EU level – a short guide

As an EU citizen, you have the right to take part in the EU decision-making process. Here, we take a look at the vast landscape of tools that allow you to have your voice heard and get involved and shape policies at EU level.

**1. Vote or run as a candidate in European elections.** Vote for the candidates whose political agenda best reflects your wishes for the EU. Throughout their mandate, keep in touch with your MEPs so they can represent your interests. EU nationals living in another EU country also have electoral rights. You also have the right to run as a candidate in elections. Find out how.

**2. European Citizens' Initiative** – As outlined above, the ECI allows you to propose action on an issue you care about and gather support across the EU. Once 1 million signatures are collected, you will meet with the Commission and participate in a public hearing at the European Parliament. The Commission will then examine the substance of your initiative and adopt a formal response outlining what action it will take or, if no follow up action is proposed, explain why not. If the Commission considers making a legislative proposal, the principles of subsidiarity, proportionality and better law-making will apply. In most cases, the European Parliament and Council will need to adopt the proposal for it to become EU law.

**3. The Conference on the Future of Europe (2021/2022)** gives citizens the ability to join the pan-European debate, organise bottom-up events, and put forward proposals that they consider important for the future of the EU. The Conference's multilingual platform has been designed to spark a truly pan-European debate, allowing for all Conference-related proposals to be collected. The EU institutions have committed to following up on the outcomes of the Conference, wherever possible.

**4. The Have Your Say Portal** allows all citizens and stakeholders (public authorities, NGOs, researchers, academics, businesses) to send their feedback and contribute to shaping EU initiatives. Share your views and opinions about upcoming EU laws and initiatives, by answering the questionnaire of a public consultation or commenting on legal drafts. The Commission analyses and sums up the feedback and contributions received. Reports become available under some initiatives. This way you can see how the feedback contributes to fine-tuning the initiatives. Learn more.

**5. The Have Your Say Simplify Portal** allows you to share your ideas on how to simplify existing EU laws. Your suggestions will be discussed by the **Fit for Future Platform** expert group. Have a look at the list of topics in the Platform work programme and share your ideas to increase their digitalisation potential, to simplify procedures and obligations linked to labelling, authorisations and reporting, or to avoid overlaps or uncertainty. You can also propose new topics. You can also propose new topics.

**6. Submit a petition to the European Parliament** regarding the way European legislation is implemented and affects your life. Petitions relate to existing EU activities; they cannot request proposals for new EU laws; they can be submitted by a single petitioner. The Petitions Committee of the European Parliament aims to provide a response to all petitions and, when possible, a non-judicial remedy to legitimate concerns on issues related to the EU fields of activity which petitioners raise.
